



# Collection Notice - CCTV and Body Worn Camera Footage

## Why are you receiving this notice?

You are receiving this collection notice because your personal information may be collected while you are attending at a WA Country Health Service (ABN 28 680 145 816) (**WACHS, we, us, our**) hospital or site through the use of Closed-Circuit Television (CCTV) and body-worn cameras (BWCs) used by our security officers.

This Collection Notice contains information we are required by the *Privacy and Responsible Information Sharing Act 2024* (WA) (**PRIS Act**) to give you when collecting your personal information.

## What information do we collect?

We may collect the following information from you when you enter one of our hospitals or sites:

- Video footage of you and/or your vehicle registration captured by CCTV when you or your vehicle enter a CCTV monitored area at one of our sites.
- Audio-visual footage captured by BWCs used by security officers. BWCs are used in accordance with our applicable policies and legislative requirements.

## What are the consequences if your personal information isn't collected?

If you do not wish to provide some or all of the personal information we collect, this may impact your ability to access monitored areas.

## Purposes for which personal information is collected and will be used and disclosed

WACHS collects personal information from you where necessary for the performance its functions or activities.

WACHS collects this personal information through CCTV and BWC to support safety and security at WACHS sites. Any personal information collected will be used to support incident investigation or review. The personal information may also be used for other functions such as clinical review and the investigation of workforce matters.

We only use or share your personal information with your consent or where authorised or required by or under law, including but not limited to under the PRIS Act and the *Health Services Act 2016* (WA) and *Surveillance Devices Act 1998* (WA).

## Who do we usually share information with?

Your information may be shared with contracted service providers (including organisations that supply and service CCTV and BWCs and contracted security officers) to the extent required for the delivery of the contracted services. CCTV and BWC footage and other personal information may also be shared with cloud service providers.

Your personal information may also be shared with Commonwealth, State and Territory law enforcement bodies, courts and tribunals, regulatory bodies, our insurer and legal representatives when authorised by or required by law.
