Key Duties/Responsibilities

1. CLINICAL

- 1.1. Ensures staff and service systems compliance with the *WA Mental Health Act* 2014 and other relevant legislation and regulations.
- 1.2. Undertakes comprehensive psychiatric assessment, diagnosis and treatment that ensure best practice clinical interventions are provided by the service to clients and their relatives and carers.
- 1.3. Acts as the point of clinical accountability for the service and provides clinical leadership for all staff.
- 1.4. Provides a broad range of therapeutic interventions in response to the range of clinical presentations.
- 1.5. Liaises and consults with inpatient colleagues and relevant external agenices in regards to patient management.
- 1.6. Ensures that a comprehensive visiting psychiatric service is provided throughout the Pilbara region, including consultation-liaison services to hospitals within the region.
- 1.7. Supervises Registrars in training and other medical officers as per RANZCP standards.
- 1.8. Participates in Continuing Professional Development, such as the RANZCPsych CPD programme.
- 1.9. Provides clinical supervision to staff as part of performance development programs.

1.10.Promotes and participates in the education and continued professional development of staff in the mental health service and related areas.

2. LEADERSHIP

- 2.1. Participates as a senior member of the service management team. Represents the Pilbara on the WACHS Mental Health Leadership group and actively participates in that group to plan, develop, implement and evaluate Area wide strategic iniativies.
- 2.2. Works in partnership with the Regional Manager (Mental Health) to:
 - a. Provide clinical leadership to the service;

b. Participates in developing service strategic and business plans, and supports strategies to achieve their outcomes;

- c. Identifying and developing strategies to address priorities;
- d. Evaluates training and development requirements of the service.
- 2.3 Provides advice to the WACHS Pilbara Regional Director, Regional Manager Mental Health and others about regional mental health services and associated issues.
- 2.4. Particpates in recruitment and selection strategies.
- 2.5. Promotes awareness in the community of mental health issues through education, training and promotion activities.
- 2.6 Performs duties in accordance with WACHS-region and program specific policy and procedures.

3. SAFETY AND QUALITY

- 3.1 Implements an effective clinical safety, quality and risk management system.
- 3.2 Fosters the development and implementation of research relevant to mental health service delivery in rural and remote areas of WA and to the specific needs of the region.
- 3.3 Monitors standards of care, work priorities, policies and processes.
- 3.4 Facilitates consumer and carer involvement in the planning, delivery and evaluation of the mental health service.
- 3.5 Develops formal links with primary care providers, particularly general practitioners, to promote continuity of treatment, shared care management and provide ongoing education about psychiatric disorders and the provision of professional support.

4. OTHER

- 4.1 Represent the mental health service on professional bodies, state-wide committees and other groups as required
- 4.2 Particpates in regional reporting processes with the Regional Medical Director.

Work Related Requirements
