

# RN, RM & Mental Health EN Benefits

## **General Benefits**

Registered Nurses (RN), Midwives (RM) and Mental Health Enrolled Nurses (EN) are eligible to receive the following benefits under the terms and conditions of the *Australian Nursing Federation–WA Health Industrial Agreement 2020*<sup>1</sup>:

- Competitive base salary arrangements
- Salary packaging
- Superannuation (mandatory 11%)
- On call allowance<sup>2</sup>
- Recall allowance<sup>3</sup>
- Overtime allowance<sup>4</sup>
- Higher duty allowance (after 5 days)
- Professional development leave (16 hours/2 days per year)
- Postgraduate qualification allowance
- Study leave (5 hours per week; work-life balance)
- Shift work allowance<sup>5</sup>
- Accrued days off<sup>6</sup>
- Travel allowance (reasonable expenses reimbursed)
- Motor vehicle allowance (reasonable expenses reimbursed)
- Distant appointment allowance<sup>7</sup>
- Long service leave (13 weeks every 10 years, then every 7 years)
- Parental leave (14 weeks paid, 52 weeks total)
- Annual leave (4 weeks/20 days)
- Deferred Salary Scheme
- Public holiday leave (10 days)
- Personal leave
- Blood plasma donors leave (2 hours per visit)
- Emergency services leave<sup>8</sup>
- Defence Force Reserves training leave (paid or unpaid leave of absence)
- Cultural ceremony leave (annual leave)
- International sporting events leave
- Witness & jury service
- Trade union training leave<sup>9</sup>
- Transfer allowance To
- Disturbance allowance<sup>10</sup>
- Removal allowance<sup>10</sup>
- Property allowance<sup>10</sup>
- Relieving/special duty allowance (reasonable expenses reimbursed)
- Uniform & laundering allowance (in lieu of free provision)
- Bringing Nurses Back into the Workforce bonus.

- 2. 18.75% of 1/38th of the rate of pay prescribed for a Level 1.2 RN for each hour or part thereof the employee is on call.
- 3. Minimum 3 hours pay at overtime rate.

- 4. 1.5 x base salary for 3 hours; 2 x base salary thereafter
- 5. 15%–100% and leave accrual
- 6. Overtime; shift work; on call; weekend absence
- 7. Reasonable expenses reimbursed
- 8. Includes volunteer leave; paid leave of absence
- 9. Maximum 10 days
- 10. For eligibility see the Industrial Agreement.

## **Other Benefits**

You may also be eligible for the following State and Commonwealth Government benefits:

- Air-conditioning subsidies<sup>1</sup>
- Home Ownership Subsidy Scheme<sup>1</sup>
- Subsidised rental accommodation<sup>1</sup> (see Tenant Rent Setting Framework)
- Zone or special area tax offset.
