# **Communiqué WA Country Health Service Board**

## **November 2018 Board Meeting**

The WA Country Health Service (WACHS) Board held its November 2018 Board

meeting in the South West (SW) inland area, including engagement meetings at the health services in Bridgetown, Northcliffe, Pemberton and the new Manjimup Health campus. In addition to engagement sessions with local health staff, there were two community stakeholder events held, one in Bridgetown and the other in Manjimup.
