## May 2019 Board Meeting

The WA Country Health Service (WACHS) Board held its 24 May 2019 Board meeting in Perth at WACHS Central Office. The meeting included a presentation and discussions with Mr Malcolm McCusker, Dr Simon Towler and Professor Kirsten Auret from **the** Ministerial Expert Panel on Voluntary Assisted Dying Legislation.
