July 2019 Board Meeting

The WA Country Health Service (WACHS) Board held its 26 July 2019 Board meeting in Perth at WACHS Central Office. The meeting included two information presentations, one relating to country dental health services and one outlining the structures and

processes associated with Commonwealth and State relations and engagement.

At the completion of the meeting the Board attended a presentation at the WACHS Command Centre, which demonstrated the capabilities and systems currently in use and a number of programs in pilot stage or under development.
