This communiqué highlights key discussions from the recent WA Country Health Service (WACHS) Board's regional engagement meetings in the Midwest region.

#### 18 and 19 March 2021

The second regional engagement visit for 2021 was to the Midwest region, where the Board visited both Geraldton Health Campus and Exmouth Health Service.

The Board toured both sites and surrounding facilities including staff accommodation, and also had an opportunity to meet with staff and receive presentations about key initiatives and achievements across the region.

The Geraldton team presented an overview of the Mental Health reform project highlights, whilst Exmouth staff spoke of the challenges in delivering health care in communities such as Exmouth and Coral Bay, particularly during the COVID-19 pandemic.

The Board also held a dedicated stakeholder meeting in Geraldton, where local community members and representatives from the surrounding shires and key service providers had an opportunity to discuss relevant matters pertinent to their communities.

Additionally, the Board were able to provide the community and staff with an overview of the highlights of the WACHS Strategic Plan 2019-24 directions.
