

BOARD COMMUNIQUE

This communique highlights key discussions from the recent WA Country Health Service (WACHS) Board meeting.

24 February 2023

The Board meeting was held in Albany on 24 February 2023 at Albany Health Campus.

Board members appreciated the opportunity to visit the facility and speak with staff during their visit to the Great Southern as part of their regional engagement program. In addition, the Board toured the Albany radiation oncology facility, as it undergoes the final stages of development. The new facility will provide highly specialised cancer treatment close to home not previously available in the region and is scheduled to be operational by April 2023.

Over the two-day regional visit, Board members travelled to Mount Barker, Denmark, Gnowangerup and Albany, spending time with staff and hearing about challenges and achievements across the region. In addition, important initiatives, including palliative care and voluntary assisted dying services, and paediatric and early years services available in the Great Southern, were also discussed.

The Board also spent time with key stakeholders at the local health sites, listening to and discussing relevant issues, challenges and good news stories happening across these local communities.
