

# **BOARD COMMUNIQUÉ**

This communiqué highlights key discussions from the recent WA Country Health Service (WACHS) Board meeting.

# 3 November 2023

The Board meeting was held in Perth on Friday, 3 November 2023 at WACHS' offices at Grace Vaughan House (GVH) in Shenton Park.

This meeting commenced the Board's focus on the refresh of the <u>WACHS Strategic Plan 2019-24</u> (the Strategic Plan). The Strategic Plan was launched in August 2019, as a five-year plan set against a 15-year horizon. The Strategic Plan has seven (7) priorities, underpinned by the WACHS values. At the meeting on 28 September 2023, the Board agreed it is timely to commence discussions regarding the review process and consider a refresh of the key strategic issues facing WACHS.

The Board focused on understanding and reflecting on the progress of the current Strategic Plan, exploring and understanding the key strategic issues and service / program performance achievements within WACHS, and looking outward and forward at the key forces impacting WACHS and the broader health sector.

The Board acknowledged achievements such as the growth and expansion of WACHS' virtual care services, improvements made to equity of access to services, the significant strengthening of staff support and safety initiatives, increased systemisation of safety and quality performance, strengthening relationships with partner agencies and deliberate investment in workplace and accommodation safety. Additionally, the Board discussed the key forces impacting health care, including workforce shortages, rapid advancements in technology and data, cost drivers and funding, and sustainability across all levels of health.

There will be further focus in 2024 on WACHS' strategic future, building on the foundations of the current Strategic Plan and incorporating a place-based care approach.
