BOARD COMMUNIQUE

This communique highlights key discussions from the recent WA Country Health Service (WACHS) Board meeting.

25 May 2023

The Board meeting was held in Perth on Thursday, 25 May 2023 at WACHS' offices at Grace Vaughan House, Shenton Park.

Grace Vaughan (1 April 1922 – 21 January 1984) was a was a member of the Legislative Council of Western Australia from 1974 to 1980. Prior to entering politics, she was a social worker, holding degrees from the University of New South Wales and the University of Western Australia. Vaughan entered parliament at the 1974 state election and served a single six-year term before being defeated at the 1980 election. After leaving parliament, Vaughan served as president of the International Federation of Social Workers from 1983 to her death in 1984.1

In recent years the building has undergone a major refurbishment and is now the offices for various directorates including WACHS Business Services, People Culture and Capability, Strategy and Change and Medical Services.

At the meeting the Board acknowledged the pleasing increase in response rate of 7% to the 2023 Minister for Health 'Your Voice in Health' Employee Engagement Survey, particularly the 41% increase in the Pilbara region.

The Board were advised that Premier Mark McGowan and Health Minister Amber-Jade Sanderson visited Albany to have a first look at the \$13.1 million Albany radiation oncology facility as the site prepared to open to patients.

The Chief Executive, together with the Regional Executive Director and local staff also welcomed the Premier and the Minister for Health to the Pilbara region to officially open Newman's brand-new, state-of-the-art health facility. The \$61.4 million purpose-built facility includes a new emergency department, inpatient beds, emergency and treatment bays, as well as a dedicated medical centre, consultation spaces and a dental clinic with space for two dental chairs.

The Board Finance, Audit and Risk, and Safety and Quality Committee Chairs provided briefings to the Board on recent Committee meetings held in the month of February.
